# Installation

- 1. Connect the Mini DisplayPort input port on the video adapter to the Mini DisplayPort port on your computer system.
- 2. Turn on your HDMI/VGA display device (i.e. television / projector).
- 3. Using the required cabling (not included), connect the HDMI/ VGA display device (i.e. television / projector) to the video adapter using the HDMI or VGA input port.

NOTE: Only one video output will function at a time.
